Socioeconomic Maps – Josh Farrow, Gateway ADD informed the RTC that as a requirement of our FY 14 contract with KYTC we were asked to update our socioeconomic and demographic maps with newly updated US census data. We received the data from the KY state data center, U of L, it was broken down by census block group. The Maps were included in the meeting materials, the maps are used to demonstrate the region breakdown for the percent population over age 60, percent disability status, percent poverty status and percent Hispanic and Latino population. Josh also spoke to the committee about standard deviation that was in the view of the maps. These maps are also included in the Public Involvement Plan.

Recommended Highway Plan – This was included in the meeting packets. The committee was informed this is the recommended highway plan and can often be changes. The final plan is expected to be released in May. The Highway Districts also discussed the newly added projects in the Region.
